BOARDING AGREEMENT

Boarding services are limited to dogs.

I

I understand that boarding my animal is not without risk and agree to the following:

- 1. All pets must be leashed or in a carrier when bringing them into The BarkMore Resort and when leaving The BarkMore Resort.
- 2. Insuring that your dog remains safe and well cared for is our first responsibility and as such we take it very seriously. We do our best, but some factors may be beyond our control. In the event that a medical emergency arises while a dog is at our facility or participating in a service that we provide it is imperative that we are immediately able to get them medical treatment at the closest available facility. We will call ahead to the veterinary offices in closest proximity geographically to us to insure they can handle the emergency present. Your pet will be rushed to the closest available facility for treatment and you will be notified. We notify the owner after we have secured a medical treatment center for the animal to avoid delays that may be caused by emotion on the part of the owner. Our goal is to get your pet medical attention as quickly as humanly possible, and any distractions may interfere with that process. I understand that in the event of a medical emergency that The BarkMore Resort, at its sole discretion, deems to need the immediate attention of a licensed veterinarian, I authorize The BarkMore Resort to seek medical attention at the closest available veterinary facility. I further agree that I am financially responsible for any medical treatment my pet(s) receives as a result of a medical emergency while attending services provided by The BarkMore Resort.
- 3. All dogs must be free of external parasites and be on some sort of flea & tick preventive. The kennet will not be responsible for fleas and ticks found on your pet as it is the responsibility of the Owner to ensure that the dog(s) is/are on adequate prevention.
- 4. I understand that while my dog(s) is fully vaccinated, that vaccines are not guaranteed and there is a risk that my dog(s) may contract a contagious disease or illness. I agree that should this occur, I am responsible for my own pet's care, medical attention and costs.
- 5. All medications over the counter (ex: vitamins) will be administered as instructed by owner. Prescription medications will only be administered as directed by the prescribing veterinarian.
- 6. Any dog left more than 5 days past the scheduled pick-up date without notification to the staff will be considered abandoned and put up for adoption. I understand that I will still be liable for the costs incurred up until the point the dog leaves the facility.
- 7. It is not recommended to board two dogs in one kennel. We recommend one kennel per dog and strongly advise against boarding multiple dogs in one kennel. Owner understands that Owner is solely responsible for any injuries/illness/death that result from more than one dog being boarded in one kennel run and any and all veterinary expenses that may result.
- 8. I hereby walve and release The BarkMore Resort, its employees, owners, and agents from any and all liability my dog(s) or I may suffer. My signature below indicates that I have read and understand this Boarding Agreement.

WAIVER AND RELEASE OF LIABILITY

THIS AGREEMENT is entered into by and between The BarkMore Resort and the dog owner signing (whether signing electronically or by hand) this document:

- 1. By enrolling my dog(s), I represent that I am the legal owner of the dog(s) and I assume all risks, dangers and responsibility for injuries to the dog(s). Owner understands and agrees that Owner is solely responsible for any harm to Owner's dog(s) while Owner's dog(s) is/are attending boarding/training/daycare. Owner understands that owner is assuming any and all responsibility for injury/harm/death of dog and that The BarkMore Resort, its Owners and employees are released from any and all liability, for injury/harm/death of Owner's dog(s) regardless of how the injury/harm/death occurred.
- 2. Boarding extremely old, brachycephalic (breeds such as pugs, french bulldogs, boston terriers, etc.), chronically ill or otherwise debilitated dogs requires extra care, which we are happy to provide. However, special-needs pets, pupples and senior pets naturally have a higher risk of injury, death, stress-related illness, or exacerbation of any pre-existing condition. As such, by boarding your special-needs pet, puppy or senior pet with us you are waiving any claim for injury, death or illness experienced by your dog while in our care.
- 3. Owner understands and agrees that during normal dog play, Owner's dog may sustain injuries that may or may not require treatment. All dog play is monitored by The BarkMore Resort employees in an attempt to avoid injury, but scratches, punctures, torn ligaments, and other injuries may occur despite the best supervision. Owner assumes sole responsibility for payment for any and all injuries, including but not limited to veterinary treatment, surgery, medications, etc. whether said injury/illness/death occurs during daycare and/or boarding.
- 4. Owner further understands and agrees that neither The BarkMore Resort nor any of its employees, staff or volunteers, will be liable for any illness, injury, death, and/or escape of Owner's Dog(s) and Owner hereby releases all of them of any liability of any kind whatsoever arising from or as a result of Owner's dog(s) attending boarding.
- 5. Owner further understands and agrees that any behavioral or physical health problems that develop with the Owner's dog(s) while at The BarkMore Resort will be handled and treated as deemed best by the employees, staff and volunteers of The BarkMore Resort, in their sole discretion, and Owner expressly agrees to assume full financial responsibility for any and all expenses arising or relating thereto. This includes aggressive or destructive behavior.
- 6. Owner further understands and agrees that Owner's dog(s) are healthy and will at all times while attending boarding have current vaccinations. Owner further understands that even if Owner(s) dog is vaccinated for Bordetella (Kennel Cough)/Parvo/Distemper there is a chance that the Owner(s) dog can still contract Kennel Cough/Parvo/Distemper. I agree that I will NOT hold The BarkMore Resort responsible if Owner's dog(s) contracts Kennel Cough/Parvo/Distemper.
- 7. The BarkMore Resort reserves the right to refuse admittance to any dog or to dismiss any dog that does not meet the health, temperament or other The BarkMore Resort standards. The determination shall be made at the sole discretion of The BarkMore Resort employees.
- 8. Owner further understands and expressly agrees that each and every of the foregoing provisions containing In Paragraphs 1 -7 above shall be in force and effect and shall apply to each and every occasion on which Owner boards Owner's dog (s) with The BarkMore Resort for daycare, boarding, or training, as the case may be. This Agreement shall remain in full force and effect as between the parties until and unless otherwise cancelled or superseded by a writing signed by the parties.
